#### Andy Harmon, State Farm:

• See attached for increase in insurance rate on an "average" car when a teen is added to the policy

- Always ask agent what discounts are available:
  - Multi-car
  - Good Student discount (See attached)
  - Steer Clear Safe Driver Discount (See Attached)
  - Car with low crash ratings (www.IIHS.org)
- Things that affect premium cost:
  - Male or Female (males pay more)
  - Accident/citation free
  - Married/unmarried
  - Children/no children
  - Cost decreases as child gets older but will still pay a premium until age 25
- Other
  - o No insurance needed during time child has permit; only needed after license is received
  - Have student sign or agree to a Young Driver Contract so that a parent's expectations and consequences are clear. Look on-line and at <a href="https://www.bmv.ohio.gov">www.bmv.ohio.gov</a> for examples of contracts.


- Reviewed Process for getting OHIO license (Available on-line at <a href="http://www.bmv.ohio.gov/dl">http://www.bmv.ohio.gov/dl</a> new driver.stm)
- When under age 18, driver must have:
  - Certificate of completion of 24 hours classroom instruction and 8 hours behind wheel with instructor
  - o 50 Hours of driving (10 at night) with a licensed guardian (MUST BE a parent or legal guardian)
  - Complete training within six month period from the time training started
- Ohio Teen Driving Laws restricts nighttime driving hours and number of other people in car depending on age (See http://www.bmv.ohio.gov/graduated\_dl\_teen\_laws.stm#tog for details)
- PDS recommends:
  - 10 hours of driving before you start classes
  - o Parents attend a free training class (See attached for dates/details)

## Accident-Free Discount (State Farm Mutual only)

If your car (or a car it replaced) has been with State Farm for at least **three** years without a chargeable accident during this period, you will receive a 10% discount on the premiums for Liability, Medical Payments, and Collision Coverages. An accident is chargeable if the driver was 50% or more at fault and State Farm paid \$750 or more under the Property Damage Liability Coverage and Collision Coverage combined. (If the accident occurred prior to April 1, 1999, payment must have been \$400 or more under the Property Damage Liability Coverage or, for a single car accident, under the Collision Coverage.) For a multiple vehicle accident, Property Damage Liability Coverage payment must be present for a claim to be considered chargeable.

The discount increases to 15% if the car has been insured for **six** years without a chargeable accident.

The discount increases to 20% if the car has been insured for **ten** years without a chargeable accident.

### Multiple Line Discount

State Farm policyholders who also have qualifying homeowners, renters, life, or health insurance with State Farm will receive a 10% discount on the premiums for Bodily Injury and Property Damage Liability, Medical Payments, Comprehensive, and Collision Coverages.

### **Multiple Automobiles Discount**

Policyholders in the same household who insure more than one private passenger car with State Farm may be eligible for our multiple automobiles discount. The discount also applies to a private passenger car if both the car and a motor home in the same household are insured with State Farm.

#### **Passive Restraint Discount**

#### **Vehicle Safety Discount**

The Medical Payments Coverage premium for many 1994 and newer cars, vans, SUVs and pick-up trucks can be reduced by 10, 20, 30 or 40 percent, depending on the claims record of your vehicle. Each make and model's claim record for the seven prior model years is reviewed annually and the discount percentage adjusted accordingly.

### **Good Student Discount**

A discount is available for male and unmarried female students age 16 through 24 who maintain at least a "B" or equivalent grade average for the immediately preceding term. Home study students and college graduates can also qualify for this discount.

## Steer Clear® Safe Driver Discount (State Farm Mutual only)

If your household includes a driver under age 25 who is rated on a State Farm Mutual Auto policy and has had no accidents or moving violations in the past three years, you could earn a discount on your policy premium. The discount is up to 15% on the premiums for Bodily Injury and Property Damage Liability, Medical Payments, Comprehensive and Collision coverages.

The driver must qualify and successfully complete the program. To complete the program, the driver must watch a video presentation, read a safe-driving magazine and complete a driver's log to document driving experiences.

In addition to the above discounts, policyholders age 50 through 74 who meet specific criteria will receive lower rates.

## Helping Teens Become Better Drivers

## 1. Be an Example

It is unreasonable to expect your child to behave differently than you do when driving or caring for a vehicle.

### 2. Be Clear

Emphasize that you will not accept irresponsible behavior. Consequences for poor decisions.

## 3. Be Positive and Emphasize

Driving is a privilege and a reward for responsible behavior.

## 4. Be Vigilant

Let your child know together you and he/she will be inspecting tires for adequate pressure, fuel level, mileage, and need for service.

## 5. Be Prompt

The longer you wait to impose consequences, the weaker the link to behavior.

## 6. Be Firm, but Gentle

Do not negotiate consequences for infractions. Let disappoint show but do not allow it to take over.

### 7. Be Consistent

Punish each infraction the same way each time it occurs. You have control over driving access. Both parents must provide a united front on issues. Do not allow yourselves to be divided and conquered.

### 8. Be Fair

Get all the facts before you take action.

### 9. Be Flexible

Zero flexibility could lead your child to drive at breakneck speeds to meet deadlines.

## 10. Be in Control-Be Alert for Games

Do not yell, scream, try to hit the non-existant brake on your side, grab the dash or distract your child

On strike: "I won't study if you won't let me have the car." Or "Nobody else can drive, You're spoiling the fun for all of us."

## 11. Be Forgiving

Your love is unconditional; withholding privileges is not withholding love. It's about keeping them safe.
